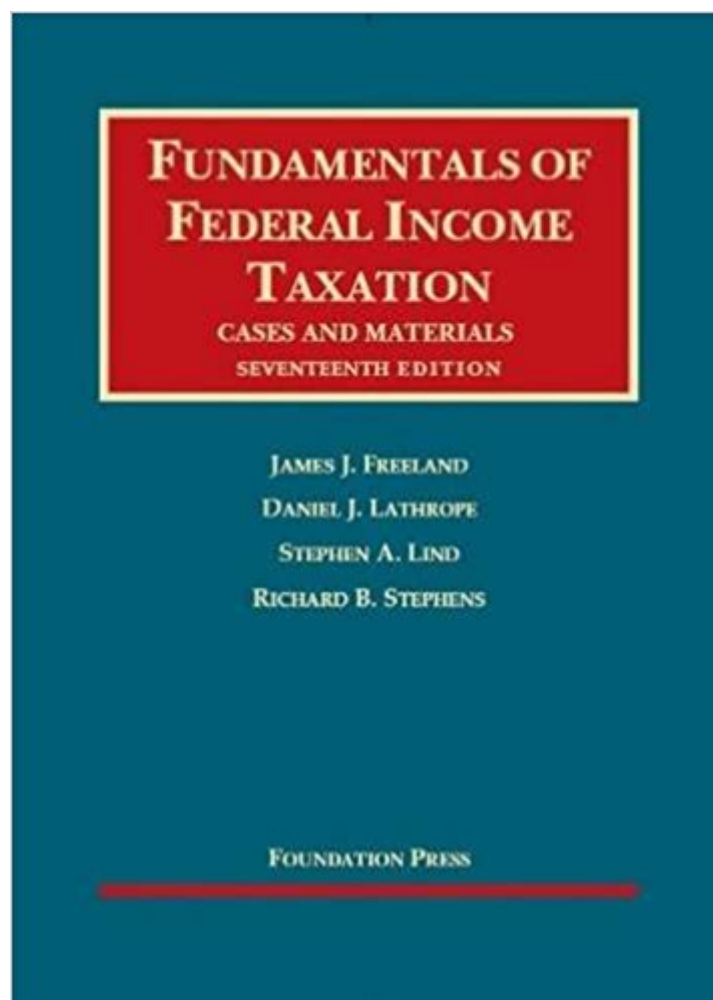

L. 112-240). The new edition contains coverage of revised tax rates, changes in the cost recovery system (§ 179 and 168(k)), revised regulations on capitalization, extension of expiring tax provisions, restoration of indirect rate increases through the phase out of itemized deductions and personal exemptions, and the new Medicare tax on unearned income (§ 1411).
